As to newspapers - I get all the Times of Natal & a shag one or two of the others - You might order the Mercury Witness & Adv. to be addressed sent to Bfst. always, because Mr. Burgess gets the Adv. & Mr. Monnell fetches [?] Mr. Osborns Witness & Mercury for our reading every evening!!! Malumati & I have not yet met. I don't think that there is much good in sending the newspaper reports of the trials to Taylor without notes. I am struggling for time to make some notes & to send the Times with the reports of some Wro, Nsuku-Zonke, Somlet & et to Frank by next mail. Have you sent any? what? & to whom.

It is ten minutes past 10, "the court" has not turned up - of course it may have got a headache, or too much or have simply overslept itself, but this has never happened before, & possibly it is waiting to get a reply telegram from PMB. "Amused" the policeman stuck in the doorway - I didn't see two men enter into the idea & talk I even laugh quite vigorously to cover us. Our 'conspiracy' on this occasion consisted in arranging to send word to his mother to hold firm & not come rushing down to see what had become of him (for wh. Mr. Othman with his experience of these ladies, might thank us) & the promise of a bath of lavender ~~water~~ water to lessen the smell of the tar wh. they dislike very much. The cells are painted about 3ft. high with a preparation more or less - quite dry, not sticky, but sweetly. We checked them up as far as

possible; & now today (Monday) has been spent in taking down the notes of those [?] weekly parties to go over the books to the Treasurer, some 200!

I broke off to write the separate letter on Reb's affairs. I have done it now as well as I can, & it frets me almost as much as saying goodbye to the uSutu yesterday - sending them back to the hillside to Zibebu's & Dick's wife's house. I hope that we have done something to cheer them.

And this family trouble makes my next proposition all the harder, for I must ask you please, My Mother to write me a cheque for £200. 'pay H. E. Gress' & send it to the Natal Bank to my acct. Mother dear if I believed that it was the way to help our Reb. I would just let the money ask you to send to him too but I am sure ~~it~~ it is not. Not just now.

You see from Frank's last letter that he feels pretty sure of ultimate success & in any case I have put my hand to his plough, & I don't see any point at why I ought to, how or could have stopped short.

Goodbye for the present Uncle dear - Mr Escrow showed me the note he sent to you, by Major's report he did much the same to the Landowner but - ~~how~~ could have done next to nothing without his help - & it was really Dobson who persuaded him to become an uSutu. As it is, I believe that they would all three have been hung but for us.
