MISSION SCHOOLS.

VERY important statement on the above subject is said to have been made by Mr. C. J. LEVEY, the respected Magistrate of Gala. It is position, experience, and the very active interest he has for many years taken in the progress of our people entitle his opinions to respect. Had the statement been made by a man whose views do not merit the same consideration we would not have felt it to be our duty to point out what is misleading in it. His words as sent on the wings of the Press are as follows:—I consider the present system in the Mission Schools in the Transkeian Territories is an utter failure. We are building up a class of Natives who may become a menace to the Colony. The dignity of labour is lost sight of altogether in these Schools and the result is that children return to their homes more useless than they were when they left.

We submit that the above statement is entirely misleading. And we regret that a man in Mr. LEVEY'S position should have made it, and that at a time when the attitude of many towards the Natives is anything but friendly. As those who are intimately connected with Mission Schools both in the Transkei and in the older portions of the Colony, we state that children who attend these Schools do not leave their homes. It is, therefore, incorrect to say, " They return to their homes more " useless than when they left." Mission Schools, as such, are put up as near the centre of a location as the circumstances permit, and the site is always chosen where the children who come to school will be able to return to their homes every day. It is only those who go to Native Institutions who can be for total prohibition, if not for black and homes. Of these Institutions the man white, at all events for themselves. This who would assert that the dignity of the labour is lost sight of would not be worth arguing with, especially after such a statement as has been given by Dr. STEWART of Lovedale in his " Lovedale, Past and Present."

But again, we think it important to explain to those who do not know the actual state of things that during the time children attend Mission Schools before and after school hours they work at their own homes just as any other Native children do. Indeed during ploughing and shearing or reaping time the real difficulty is to get children to come to school. It is incorrect to speak of these children, as if during their school period, they had no work to do, and that they were brought up with the idea that to read and write were the only necessities of life. In this connection Mission Schools are only a part of the daily life in a Native Location, and although Mission Schools have now existed among our people for several years we submit that the class Mr. LEVEY speaks of has no existence. At Mission Stations or Native Locations there is a number of children who through the carelessness of their parents never attend school, and we can testify from abundant experience that these children do not work more than those who attend schools. Our contention is that Mr. LEVEY'S statement is loose and misleading, and that no such a class as he refers to has been or could be the result of the present system which plants a school where the teacher and the parent will work hand in hand. Of course our remarks do not deny that there may be room for improvement; but the system as such has answered fairly well, and the charge made against it in the statement under consideration is undeserved.

BANGMAKERY.

THE much-talked-of Trek has ended exactly as we expected it would—in dust and smoke. It was too late in the day, after Mr. RHODES had exploited the regions to the North of the Limpopo, which at one time were supposed to be

impregnable, for any body of men to start a movement such as the one about which we have heard so much, with any hope of success. To begin, not taking into account the almost endless military resources of the Chartered Company, there was the voice of South Africa against it. The Trekkers could not expect to be countenanced by the Transvaal, which knew that if nothing has ever deeply ruffled the temper of the British Lion, any expedition of this sort started under her auspices would open up subjects involving her own independence, which she prizes so much, and not without reason. Where, then, were the Trekkers to get support? At signal we believe Mr. RHODES could have set on them the formidable manslaying machine " which LOBENGULE, like CETYWAYO, has reared ; and the Trekkers would have been smashed. None knew this better than the Trekkers themselves. The gyrations they have been indulging in have therefore always appeared to us as harmless as they were unreal; in short, as a sheer make-believe, or, to use the emphatic Taal, bangmakery pure and simple. Our political leaders are to be congratulated that they have sustained from this hideous dream nothing more serious than a shock to the system. This much we have always felt, that even if the Trekkers did go into the British sphere it would be as peaceful and dutiful subjects of the Company, and not as its enemies.

THE LIQUOR BILL.

THE principle of the Government Bill, for the regulation and restriction of the Liquor evil, has been well received by the country. The Bill requires amending in two respects to render it a complete measure of its kind ; and we trust Ministers will see their way to adopt the amendments, without which their Act will be a dead letter so far as practical purposes are concerned. One amendment is that for the purposes of the measure Hut-Tax Payers in Native Centres should be given the status of voters in connection with the Local Option clauses. It will be generally conceded that it is the outcry of the Natives that has made legislation in this direction imperative. They were spoken of as leaving or returning to their homes, but for black and white, at all events for themselves. This is granted them by Government in the shape of Local Option. But Government must have overlooked the fact that by far the greatest majority of the Natives are not Registered Voters ; and that, therefore, the concession of Local Option in the form proposed will not benefit the Natives one white. It is only in the manner we suggest that Local Option can be made to promise some prospective benefit for our people. The Legislature might well grant them this, as otherwise, to give our people the Bill as it stands, and nothing but the Bill, would be giving them a stone in the place of the bread for which they asked. Yet another very sensible amendment has been thrown out by Mr. VICTOR SAMPSON, Barrister-at-Law, a gentleman who has long evinced a deep and enlightened interest in public affairs. We hope the day is not far distant when Mr. SAMPSON may grace the Legislature with his presence, as we are assured it would not have a more diligent and intelligent member, who would in every way be a credit to it. Mr. SAMPSON is more concerned with the principle underlying the sale by the bottle; and makes out a case bottle ; against it which seems to us as irresistible. The Government would be wise to embody it in their Bill. " There is no greater curse to the country," writes Mr. SAMPSON, than the licence to sell by the bottle. I speak from observation, and I could produce the most conclusive evidence to prove that the greatest amount of crime is due to the half-bottle (pint) which is bought at the canteen or bottle store, and consumed, far away from police or other supervision, in the hut or veldt. The principle, therefore, of the Government measure, in so far as it permits this evil to continue, is wrong. We should strive for the regulation of drinking in public. By regulation I mean that no canteen-keeper or other licensed victualler should be allowed to sell to any native or person frequenting the canteen, liquor to be carried away. It should be consumed at the counter, and three or four convictions for drunkenness upon the premises should render the licence liable to forfeiture. In this way we should enlist the licence holder on the side of temperate drinking, without depriving the subject of his right to a glass of brandy if he wants it; we should restrict

" amount consumed to moderate " proportions, and do something " more practical to stay crime than " the doubtful measures of excise or prohibited areas."

These two amendments given due effect to would, in our opinion, render the Bill a workable one.

Notes of Current Events.

PEOPLE will breathe more freely after Mr. SUPERINTENDENT Sauer's remark at OF EDUCATION, Stellenbosch that Government, convinced that no one from abroad would be in a position at once to pick up the details of the educational system of the country, were trying to induce Sir Langham Dale to remain at his post a little longer. We are pleased to find that the protest entered against the importation of a Superintendent General of Education, in which we joined, has not been in vain ; - and it is to be hoped that when the time comes to relieve the present respected head of the Education Office no fancied difficulty may interpose itself in the way of the Government in nominating Sir Langham's successor among the galaxy of eminent educationists in this country.

We take over from a NATIVES contemporary the statement AND DRINK, of a fact, not because there is anything original about it, but because it comes from a distance, and emphasizes what has been repeated times without number. It is as follows:—" During the discussion recently of the new Liquor Bill at Kimberley, one argument used by one of the speakers, who has had considerable experience with Natives, was that while he had known many Natives who abstained altogether, he had never known one who, being in the habit of drinking, drank temperately, and therefore there was reason for their being put under a more restrictive law than the white population."

TUE Commissioner of HON. Crown Linds spoke at MR SIEWRIGHT the Bond ??? in AT Uitenhage. Uitenhage it was to be expected that he should refer to the fact of his membership of the Bond which he has kept up in spite of personal imputations ; and that his colleague, the Secretary for Native Affairs, was also a Bondman. Of the Premier, he said that " though not a member of the Bond, no one present had its true principles at heart more." Mr. Siewright was significantly silent about his other colleagues—Messrs. Sauer, Merriman, and Innes. We hope it may not be because he deems them less devoted to the interests of their country. There is an indication of a policy, however, in the Commissioner's deliverance which we trust will gladden the heart even of a stickler to Constitutionalism like Mr. Tamplin. We admire the declaration that " the policy of the Ministry, shortly, was not to unduly mortgage the future of the Colony, but to develop its internal resources, and to do nothing which should unduly traverse the sentiments of any section of the population."

AMONG BILLS TO BE ??? SPECTIVE SUB-LEGISLATION. mitted to the fourth coming session of the one to amend the law of the Estates of Deceased Persons, Minors and others. The measure is a very important one indeed especially in so far as it affects the more advanced class of our countrymen. These people, to show that they had taken up civilised life, went in for buying land or otherwise securing titles to their holdings. At death, not knowing that the State has to deal with estates, left all to their heirs under the impression that everything would be dealt with under Native custom. The result has been misunderstanding leading to confusion ; and we believe to day more than half the estates of deceased Natives are not held under proper legal title. The Attorney General would do the people a service, while he is about amending the law on this subject, to make necessary provision for fixing matters in the case of Native estates.

It is not complimen- NOT tary to the rulers of COMPLIMENTARY, this country to learn that one of the objections some people in Bechuanaaland have to being annexed to the Cape is that they fear that annexation would simply mean the sweeping away of the Bechuana- Our people THE GLEN GREY have learnt with much regret LAND. that Mr. W. B. Chalmers has been unable to accept the appointment to examine into the grievance of the Glen Grey people which was ventilated in these columns a few weeks ago. Mr. Chalmers would have proved a Commissioner such as our people would have the utmost confidence in ; and his report would have carried weight with all parties. His health would, however, not permit of his undertaking the mission. We understand that Mr. Hemming, the Civil Commissioner of Grahamstown, has been asked by Government to prepare a history of the settlement for its information and perhaps no better official entrusted with the work seeing that Mr. Hamming must have gained much knowledge of the facts when he acted as Chairman of the Tembuland Settlement Commission, after the last war. Mr. Francis Graham the Civil Commissioner of Dordrecht, has, we believe, been sent to look into the Agnes survey, and report. It is gratifying to learn that Government has no desire to act unfairly towards the people of Glen Grey.

ALARMIST It is to be S' regretted that there should be people in the Transkei anxious to foment disquiet.

Some people have profited largely by war ; but we hope their efforts will fail to promote a scare in the territories by manufacturing, as a correspondent of the Cape Times does, such stories as those impugning Sigid's loyalty. It must have been the same writer who concocted the account of the conspiracy of this chief and Rili in the Dispatch a few weeks back, but his story in the latter paper has called for such a rejoinder as has removed every suspicion which the mischievous scribe sought to raise in connection with Sigid.
