"The ambition of a dynasty once more hopeful of re-establishing itself in its former power, the fierce desire of a party eager to take revenge upon those who have opposed it, and the passions of individuals bent upon gratifying private animosities, are all motives which move to the commission of great crimes; and when it is remembered that none of those motives are wanting to the Usutu party, that the Usutu leaders are elated by the overthrow of Usibebu, that they are freed from all restraint or apprehension in that direction, that they are badly advised by irresponsible partisan advisers, and that they rely upon the support which they believe they will receive from their Boer allies in case of need, it is not to be wondered at that those who are responsible for the peace and safety of the Reserve territory should find cause for grave anxiety in the present state of things in Zululand.

That the Reserve territory is exposed, in consequence of the course of recent events, to a great danger there can be no question. It is a danger, however, which must be met and resisted because otherwise

not only will the honour and good faith of the Government be sacrificed, but the peace and good order and the safety itself of this neighbouring Colony of Natal will be imperilled.

His is the result of Boer interference - their intentions are yet unknown. But it is our duty to defend the Reserve by all means at our disposal

The Council had decided that, as the proclamation was not in accordance either with the ancient customs of the Zulu Nation nor with the terms of the restoration of Cetshwayo, no notice could be taken of the latter until instruction from HMG had been obtained. The Boers appear to have had considerable trouble to induce Mnyamana to cede the land they wished to have. The Usutu chiefs, assisted by Mr. Grant, did all in their power to retard the formal act by which protion of Central Zululand would be ceded to the Boers. He also exerted themselves to the utmost to reduce the extent of territory demanded. The Boers, however, resoultely adhered to their demand, which has ultimately been acceded to by the Usu u. Eight hundred...farms are to be fiven them, 530 odd of which are to be 4,000 acres in extent, and 260 odd, 2,000acres in extendt. The land for these farms is being surveyed, and the 'sutu will retian possession of the remainder of Cetral Zululand.

/In return the Boer will give the 'suthu military assistance against any outside power ~~ex~~ if threatened or are unjustly treated if they consider the 'sutu to have a fair and just case. This is the imort (Pret undersantds) of a document signed by the Boers and Usuthu.

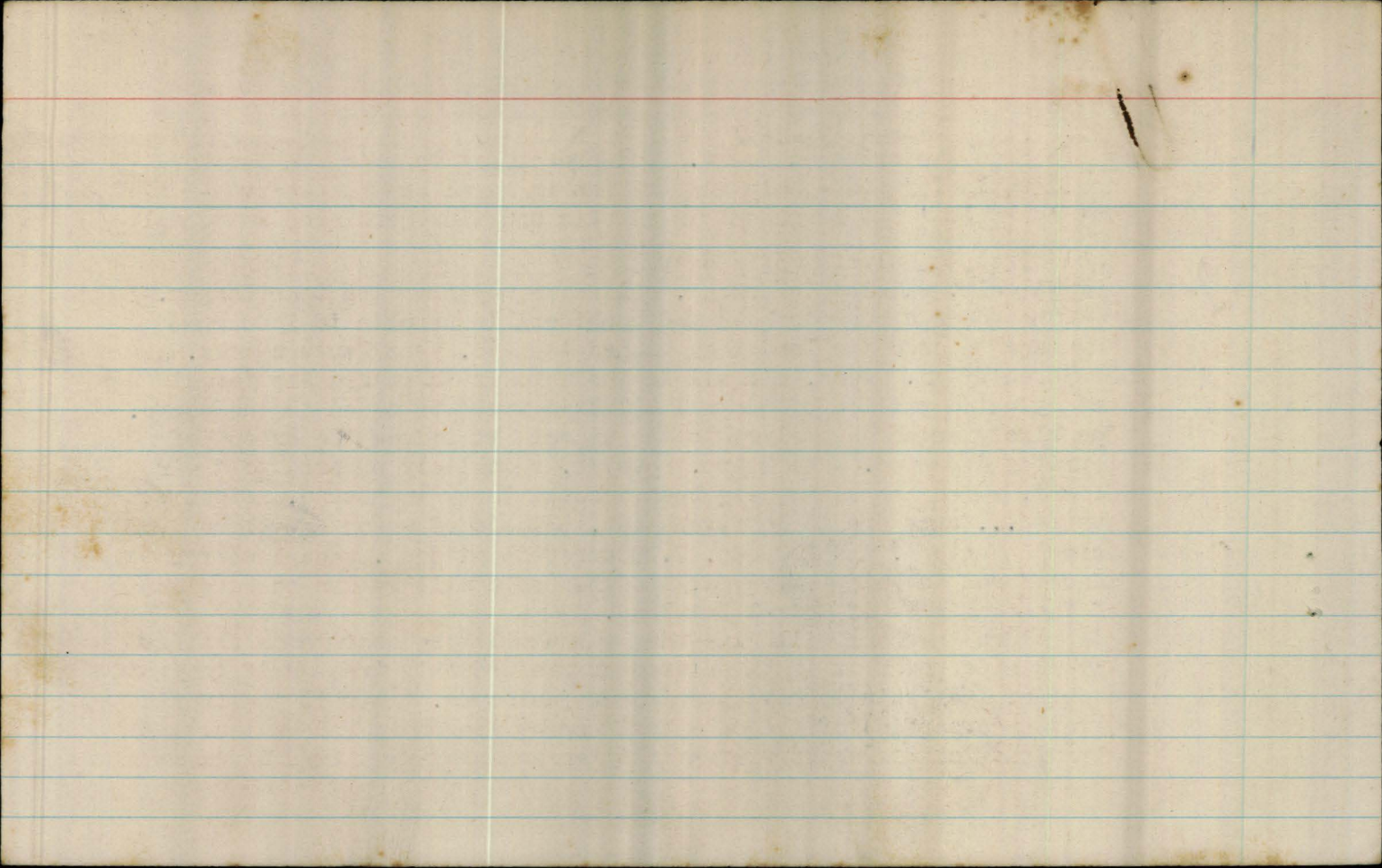

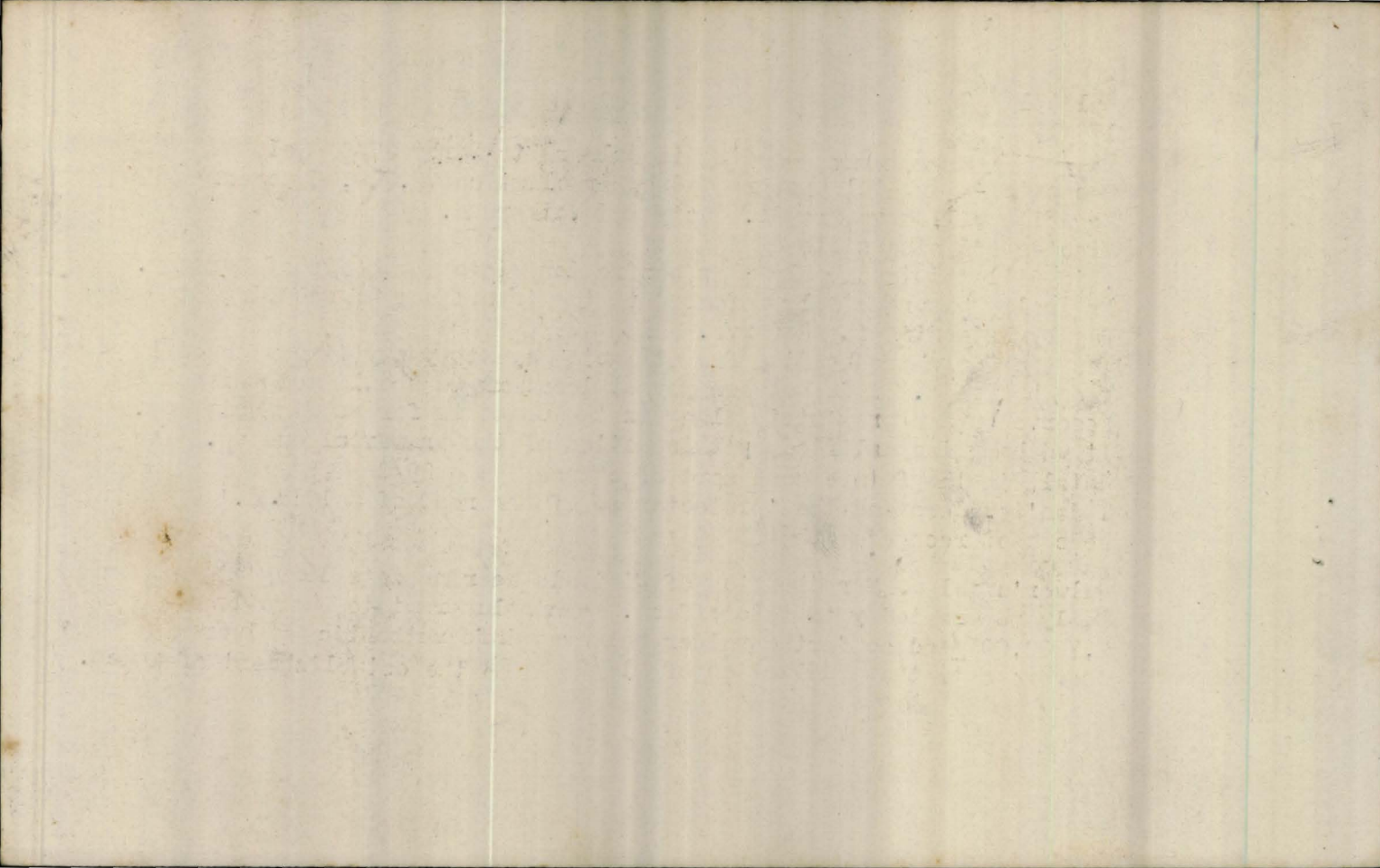

It is of urgent importance to make a distinct representation to Germany as to the British requirements in South Africa; and in reply to this letter it would be well to request the Foreign Office to inquire whether there is any foundation for the statements now sent and to say that the British Protectorate of Bechuanaland extends northward to the Shoshong and westward across the "Kalahari desert", and that Sir C. The 843 treaty says that a commission will mark the boundaries but this commission was never appointed and no positive act of annexation took place and it was not renewed. After the war, and England have not involved itself in Zululand since the war, and in a despatch said it would not extend its authority or influence beyond the Reserve.

Memo on draft paper on the protest note.

This is only a draft 1. On what grounds does Germany base her right to interfere without consulting H.G. All she does is say it has been acquired from a German subject from some ^{one} (who it will be shown had no title to grant it) But if a German subject had the right to obtain land in St Lucia then the rights of the traders at Angra Pequena should invalidate the German claim. But HMG do not consent to argue with A Pequena because this would not be friendly nor supported precedents of international law.

First it is incorrect to say that the flag was raised as a consequence of the news of Luderita's claims for the instructions were given before the news reached HMG through German newspapers / and so the argument continues / ~~at least~~ Count Munseter next proceeds to argue from the language of English ministers that Zululand is independent and that therefore St. Lucia Bay is not British. It has been shown that HMG has not regarded St. Lucia Bay as an integral part of Zululand as it was severed from it by the Treaty of 1843. / But HMG do not admit and indeed distinctly deny the independence of Zululand in the sense suggested by the German Government, and it

Gives history of the war

"Again after the late Zulu war Cetwayo and his family were deposed from the succession by the Engosih Government and the country divided into thirteen chieftainships each chief being bound by elaborate conditions to the British Government. In 1881 the British government still controlling the Country, unmae several of these appointed chiefs, separated the territory of one of them...from central Zululand, took part of the country for itself...and appointed Cetwayo ruler of the rest....

But the British Govt did not revoke the deposition of his family generally from the succession declared by Sir Garnet Wolseley in 1879 and it reserved the right of approving his succession. Cetwayo died in 1884, and the youth Dinuzulu has proclaimed himself his successor; but the British Government has not recognised him. The family which he is sprung, has been deposed from the succession and

since his accession and had not more de facto authority there than he had de jure authority.

The Parliamentary declarations to which Count Munster appeals as indicating a determination not to interfere in Zululand were not intended as explanations of policy such as would be offered to a Foreign Government. They had exclusive reference to the immediate question before the British Parliament, which was whether H. Government should intervene in the particular quarrel which has been raging for some time between the "sutu and Anti-sutu factions and H. Govt decided that it would be well to let the parties settle their differences among themselves, as it was uncertain which party had most right on its side.

This would have been sufficiently apparent to the German Government if they had overlooked the most recent and most authoritative declaration made in Parliament on this subject. On the 14th November last Mr Galdstone stated in the House of Commons that "the attention of the Government is being directed to the condition of Zululand with the view of considering the question whether these obligations of honour or policy are involved in an interference in its affairs. The moment they see that the time for such interference has arrived they will deem it their duty to make it known to the House."

/Therefore it must be clear to German Govt that HMG/ "resist any attempt to introduce the authority of any Foreign Power into Zululand. They maintain their paramount control of that country from a conviction that the Colony of Natal and the Reserve would be endangered if they were to forego the ultimate right of controlling the trade in arms and alcohol along the Zulu coast."
